A mark of 7 is given in the Stamina dimension of the Enlisted Performance Evaluation for the period ending 31 MAR 04. Petty Officer Sanders frequently worked long hours to provide CASREP support for ship and shore based electronics throughout ESD GalvestonA; AOR. When credible intelligence identified the Houston-Galveston ship channel as a potential terrorist target, Petty Officer Sanders worked through the Christmas and New Yearâ;s holidays with ET2 Mondeci to provide support for MSO Houston as they implemented MARSEC condition II. He worked all Christmas day to set up contingency communications at MSO HoustonÂ;s |Incident Command Post (ICP) for Operation Paladin III, installed a spare Motorola desktop VHF site controller, and then worked until 1:00 in the morning to reconfigure NDS control circuits to provide MSO exclusive use of Group Galveston¿s Houston VHF high site. Despite rare Friday after Christmas holiday, he made repeated trips to MSO Houston, MorganÂ; s Point, and the Houston cruise ship pier that provided training for ICP watch standers in VHF communications, reconfigured the CGC HeronÂ;s L-760 and ST-60 depth sounders to restore sounder operation without available spare parts, and repaired radars on 25Â; RB-HS boats used to transport Sea Marshal teams conducting 100% boarding of all vessel traffic entering the port of Houston. When CGC Seahawk was TAD in Sabine for MARSEC-II Homeland Defense Security patrols, Petty Officer Sanders worked four consecutive 14-hour days to troubleshoot a multitude of electronics problems. He repaired the EML-500 Doppler speed log and performed the long tedious underway milepost calibration adjustment. While underway, he reconfigured faulty software settings for the ECDIS Master Computer that restored electronic charting and auto pilot capabilities, and recommended CASREP remarks that initiated replacement of the unreliable ECDIS back up laptop computer. He also repaired the VHF transmission line for the Ross DSC-500 transceiver and replaced a faulty GPS antenna. He successfully troubleshot elusive problems with the V-850 and ST-60 depth sounders and provided corrected sounder wiring diagrams for ESDD Panama The Officer in Charge of the Seahawk personally complemented ET3 Sanders persistent dedication that restored reliable electronic communication and navigation capabilities for their security patrols of sensitive waterfront petroleum facilities and off shore oilrigs, and restored the BMCSA¿s confidence in junior Coast Guard ET3s.

Petty Officer Sanders consistently worked long hours and extended workdays to provide maintenance support for ship and shore side electronics throughout ESD As the project petty officer for the CGC SkipjackA¿s Galveston¿s AOR. Electronics Readiness (ESR) groom, ET2 Sanders coordinated cutter availability schedules with Group Operations, SkipjackA; Officer in Charge, and Allied Technology Group contract personnel. Before the groom team arrived, he worked on Saturday to inventory a weekend delivery of test equipment, tools, and spare parts, and then worked extended workdays with the contractor throughout the week to verify installed field changes, measure performance specifications of communications equipment, and helped test and troubleshoot weather deck antennas during a week of relentless rain showers. When work fell behind schedule, he worked thru dinnertime three days in a row, and then worked until midnight on Friday to help troubleshot an elusive WSC-3 UHF secure communications problem. He came in early the next morning, ordered XB and DLR replacement modules used during troubleshooting, helped contractors pack tools and test equipment, prepared last minute DD-1149 shipping documents, and arranged a FedEx shipment to Seattle, to meet the contractÂ;s scheduled work on the West coast. The ATG team leader and the Skipjack OinC both complimented Sanders dedicated work that successfully completed the cutters ESR groom, met the contractors schedule deadline, accomplished annual planned maintenance procedures, and maintained operational readiness of CGC Skipjacks When paged by NAVCEN for a late night failure at communications suite. Angleton DGPS site, Petty Officer Sanders discussed failure symptoms with Raytheon Tech support contractors and reviewed troubleshooting procedures before leaving ESD. When he arrived at the remote site, all equipment appeared to be working normally, and without the benefit of DGPS C school training, he conducted a functional test of satellite receivers and the MF transmitter, verified normal equipment operating parameters, and coordinated remote control testing with the NAVCEN watch stander. Before leaving, he completed a walk thru survey of the site, discovered aircraft warning lights on tower were out, and reported the outage to NAVCEN to initiate a Notice to Airman message to warn pilots of potential aircraft collision hazard. In addition to long hours as an electronics technician, Petty Officer Sanders served as a PCS sponsor and provided timely unit specific information for a new SNET, coordinated a successful housing search with local apartment rental agencies, facilitated a smooth transition from A school to ESD, and created positive first impression for ESDA; s newest and most junior member. He also completed off duty college classes, shared Coast Guard Tuition Assistance lessons learned with other crewmembers, and encouraged all ESD personnel to participate in off duty education opportunities. He volunteered as ESDA¿s representative on the Group Galveston Human Relations Council, raised more than \$120 as Coast Guard Mutual Assistance representative, and served off duty hours as president of Wellesley Campus Ministries, and completed 500+ hours of community service with a local church group and Galveston Island relief agencies.

Professional, Specialty Knowled Rating 7 Superior

Assigned a mark of 7 in the Professional/Specialty Knowledge dimension for the period ending 31 Oct 04. Petty Officer Sanders displayed outstanding knowledge maintaining electronic communication and navigation equipment throughout ESD GalvestonA¿s AOR. When Station Freeport reported problems with the CG 47319s Auto Helm, ET2 Sanders successfully troubleshot the Ray Pilot 650 without the benefit of formal training. He identified water intrusion in the display unit and replaced and a defective microprocessor control module. He installed shop spare control unit, got underway with the station boat crews to verify computer controlled auto helm operation, prepared DD-1149 transfer documentation, and ordered XB spares to replenish expended shop stock. Once the system was operational, he drafted ¿as built¿ wiring diagrams to streamline future troubleshooting and conducted training for Group EMs who will be inheriting support of 47 MLB autopilot systems. When Station Galveston asked ESD to retrofit the electronics package on the CG-213515, ET2 Sanders volunteered to serve as the project petty officer and devised a plan to use the best electronics from the 515 and the recently surveyed CG-21512. He removed electronics from both boats; bench tested all the equipment, and overhauled the radars, depth sounders and VHF radios. He helped the Group DCs and EMs fabricate a new radar pedestal, antenna mounts, and speaker brackets. when all the welding work was finished, he installed new roll cage wiring and reinstalled the electronics suite that improved the reliability of small boat communications and navigation without the expense of purchasing new equipment. ET2 Sanders also completed extensive on the job training on AN/SPS-69 radars, and successfully cannibalized out of production radar systems from excess property to provide ready spares for 13 SAR and AtoN platforms in GalvestonA;s AOR, that minimized down time of search and navigation radars in spite of unavailability of replacement parts. He also conducted thorough research and shop training on options to provide differential positioning information with obsolete GPS receivers on 47 MLBs, 41 UTBs, and 75Â; WLIX cutters. And as duty Electronics Technician, Petty Officer SandersÂ; outstanding technical knowledge also quickly addressed CASREP outages that replaced Ray-430 loudhailer on the CGC Heron, repaired the JRC radar for Station GalvestonA¿s CG21521, and restored Pecan Island NDS site that provides distress calling and SAR coverage for Group Galveston Station Sabine, as well as Group New Orleans.
